

## FROM THE COMMITTEE

Another successful AGM was held at Cobargo. Thank you to all those that catered, it was outstanding! With overfull tummies the committee and our members would have all went home feeling very encouraged with the AGM outcome and the discussion that occurred during the following “normal” AFA meeting. Congratulations to the incoming committee, all the best with your ongoing battle for access to our public lands for all our community members (not only walkers but disabled, horse, bike riders (motor & pushbike) & 4WD enthusiasts).

The committee & AFA members have been encouraged of late with some hint of change in attitude within state government corridors. Review of the NPWS Horse Riding Policy & the proposed trial of horse riding and its affect in selected Snowy Mountain areas along with State government request for submissions in relation to how public lands are used somehow offer some feeling of maybe being heard.

On behalf of AFA members the committee has been busy writing submissions to various government bodies and the NPWS in regard to these inquiries...and of course not receiving any reply..... Submissions can be viewed on the AFA website.



In reply to the draft “Strategic direction for horse riding in NSW National Parks & Reserves part of the AFA submission states that AFA would like to see more than one track in one wilderness area opened up. As mentioned only the Snowy region is being considered for a 3 year trial period. The submission goes on to state “We do not see the need for a three year study as these tracks were regularly ridden prior to the wilderness declarations. An inspection now will reveal if any degradation has been caused by past users bearing in mind that any tracks, anywhere, require some maintenance from time to time. AFA has cooperated with NPWS in maintaining tracks since horses were prohibited and it is somewhat unreasonable that they cannot be ridden, just maintained. We want to make sure these historical bridal networks of tracks are preserved”.

While there is hope for some historic horse tracks to be opened it will still be prohibited in wilderness areas according to legislation within the Wilderness Act. AFA is lobbying to have “corridors” through wilderness areas and legislation will be required to change within the Wilderness Act to provide certainty & to protect any gains made.

AFA representatives continue to meet with advisors to the Minister for Environment, Robyn Parker and Andrew Stoner along with Bob Conroy, Director General of NPWS, the Shooters & Fishers Party & Fred Nile to lobby for change in legislation.

Review of AFA aims & Objectives: It was decided at the Cobargo meeting that these deserve more discussion and as time was getting away at the meeting it was moved that they be held over until the next meeting in September. This would also give members more of an opportunity to consider if changes need to be made. If you would like to make comment and are unable to attend, please contact one of the committee who make sure it will be relayed to those in attendance at the September meeting for discussion.

A reminder of them just in case you did not receive the last newsletter...Objectives of AFA:

- To promote preservation and conservation of our natural and cultural heritage in the bush
- Ensure non-discriminatory access to the bush for all who wish to use it for responsible recreation, education and enjoyment
- Ensure forested areas are responsibly managed for maximum benefit of the wider community

These objectives are achieved by wide community consultation and support, lobbying government at Local, State and Commonwealth levels, providing a forum for discussion for relevant issues, raising funds to support the achievement of our objectives.

Functions of AFA:

- AFA is dedicated to opposing further Wilderness Declarations in NSW on the grounds that doing so will deprive the people of access to and enjoyment of their natural and cultural heritage.
- AFA continues to lobby for open access to all public lands to responsible users and for education, recreational and cultural purposes
- AFA is a forum for the discussion and resolution of issues concerned with the use of and access to public land.
- AFA continues to lobby for responsible businesses that use their access to public lands to promote community support for all user groups to be able to access public land and wilderness areas not just bush walkers.
- AFA undertakes to inform the public and Government at all levels of these issues
