## FROM THE COMMITTEE

On 31st May 2008 AFA held its AGM. This year it took place at Brian & Marliyn Clarke's home. Their home provided the perfect backdrop for an AFA meeting...overlooking the Duea National Park, the weather was warm & sunny.

What more could we have asked? More members present would have made the day perfect. Although there were 30 plus present, this included some new faces; we have some 500 members so the committee were a little disappointed with the numbers. Quite an effort is put into the general running of AFA & the AGM, all of which is voluntary & a few more members present at the AGM would have shown encouragement to those volunteers to maintain their effort. The committee is aware that their members will be there in "a crisis" but work behind the scenes must continue for AFA to remain a reputable & recognized community group within the NPWS & "Extreme Green" organizations.

This is an appropriate time to remind all that if not for past lobbying by AFA your access to some of your favorite camping & driving areas would be a wilderness area with no access available to you or your family unless they can **walk** long & often rough distances. Access to our native bushlands & heritage is being challenged daily by the radical Colong Foundation. Their support from politicians, high profile community members & celebrities is far & wide.

As a group they are powerful lobbyist & able to employ or commission consultants to develop any type of document they choose that will support their agenda of more wilderness areas. They have politicians who can keep them up to date with changes in guidelines, policy etc. Their committee membership consists of people with titles after every committee member i.e. B.A., O.A.M, B.Sc. Q.C. etc. They have little time for

National Park management when it comes to increasing wilderness areas.

AFA members beware. In their latest bulletin they have mentioned that The Colong Foundation has commissioned John Macris to develop a procedure to determine the relative importance of proposed changes to recreation opportunities brought about by wilderness proposals ...to find ways to protect key areas like the Deua."

Bendethra is in the Deua....think about this & what Bendethra means to you, your family, our heritage and then think about your AFA membership & why you are a member. Support your committee, they may not have letters after their names but with your support they will try their very best to maintain access to our public lands.

**AGM** - The outcome of the committee elections were not surprising with many of the office bearers re-elected unopposed. Bryan Clarke chaired the meeting whilst office bearers were being elected. Some changes of note were:

They recently were successful in having the committee recognize & look at preserving the social history, bridle tracks and farming background of the Upper Deua River and to also place the remaining two homesteads Woolla & Alpine on the shire's heritage register. During their survey it was acknowledge by the chairman of the committee that the network of bridle tracks through the Deua regions were significant because they provided links to the coast for Monaro, Braidwood and the Southern Tablelands.
