While Joan Webb is pouring hours into preparing the AFA submission on the South East Escarpment Plans I will attempt to fill her role for this addition of the newsletter. Please don't expect the usual high standard! It is gently raining on the roof outside. Hopefully it will continue and spread.

The weekend before last John and I were fortunate to spend three days riding in the Deua River area with Terry Hart and Joan and Reg Webb. For those of you who ride these areas often I now understand why you are fighting so hard to protect them from mindless bureaucracy. To ride along a bridle path over a hundred years old overlooking a crystal clear river and listen to the stories of how the early pioneers used these incredible networks of trails brings home to you how fragile our grasp on them is. To picture men and women on horseback herding pigs and even tar-footed turkeys along these narrow and sometimes treacherous paths was poignant for me.

There are two major heritage issues at stake here. The first is the actual loss of the paths themselves but equally as important is the possible loss of the human heritage. We currently have a group of people who not only know the trails and tend to them but who tell the stories about the people who used them long ago. If these paths are locked up we not only risk losing them to our relentless bush but within a generation the stories will fade too. Unless our current riders can take the next generation on horseback along these trails and share these stories a passion for them and their history will not be lodged in the psyche of our young.

It is nothing short of cultural vandalism to put a padlock on such an integral part of our bush heritage.

#### • <u>SEEMP SUBMISSIONS</u>

Sincere thanks to the committee for the preparation of our AFA submission to the NPWL regarding the South East Escarpment Management Plan. They have produced fourteen pages of valuable response on our behalf. The final draft will be reviewed by Neil Waddell and delivered this week.

However there is impact in numbers where the government is concerned. If you have put yours aside please dig it out and get it in. If you need more time contact the NPWL Office Narooma on 44762888 and request an extension. In light of some difficulties with misplaced documents in the past it would be advisable to request a "delivery" and "read" receipt. It may be even worth backing up an electronic submission with a hard copy. Peter has suggested we hand deliver the AFA document. There may be some wisdom in that. Regardless of whether your particular interest is horse riding, 4wheel driving or fishing we are talking about the heritage of countless generations to come. This is our opportunity to have our say. Do it!!

## • <u>HERITAGE</u>

Congratulations to Peter Smith and Terry Hart who were successful in their application for a \$1000 dollar Heritage grant towards the research phase of mapping bridle tracks. Peter kindly represented AFA and was presented with the award at the recent Royal Australian Historic Society State History Conference by Mr Michael Collins, the chairman of the Heritage Council of NSW. Whilst the amount is not grand we can assume it signifies recognition by the Heritage Council of the importance of these bridle paths in the cultural fabric of our history. After considerable discussion at the September AFA meeting it was decided that because of the natural limits set by the small amount of funds, one track should be mapped in detail with the others to be identified for future mapping. As with everything involving a grant the forms required to be completed for this were worthy of hundreds of thousands rather than one so we thank Terry and Peter for all the work required to gain this recognition of one facet of AFA's cause.
