NSW Archives State Records, 143 O'Connell St. Kingswood (0296731788); National Archives of Australia, Queen Victoria Terrace. ACT; Lands Dept for maps; NSW Births Deaths & Marriages (births up to 1905, deaths & marriages to 1945). Calendars- these continue to generate constant sales even though the year is half way through. #### HERITAGE

This area remains one of Access For All's main focuses. A tender will be placed with the NSW<sub>A</sub> government for AFA to be a **consultant** regarding heritage issues. If successful AFA will be a consultant to government & NPWS decision makers. AFA will be able to provide valuable information on the heritage value of our bridle **trails/tracks** and the need to maintain access to important community heritage sites.

# • NEWS FROM YOUR COMMITTEE

At the last committee meeting (28<sup>th</sup> May 2006) members of the committee expressed concern about a number of recent comments made to them from members and others. These comments relate to the alliance Access For All has with the NPWS, that is that it is becoming a little too "chummy" with the Parks. The committee would like to reassure its members that this alliance is certainly not "chummy", far from it! It is important that open communication is kept with the NPWS so **AFA** is able to maintain a spokesperson for its members so access to the Parks does not become more restricted than it already is. To do this it is important to keep a professional working relationship with the NPWS. Should any members feel strongly about the committee's dialogue with the Parks, regular minutes & tabled minutes of meetings with the Parks are available. Thank you to those that have brought their concerns to the committee. The committee encourages all its members that have ideas or complaints that they bring it to the notice of member of the committee so your thoughts can be discussed & acted upon within a timely manner. Like all organisations it is important for Access For All to have input from its members to maintain focus & direction which will benefit all. not just the committee.

A request from the committee that if landowners are having problems with wild dogs that they need to put incidents in writing to the NPWS and forward a copy to a member of a dog committee in your area, otherwise the incident never happened. Members report dog activity high but NPWS report little or no activity as none have been documented. Members of the Wild Dog committee in the Braidwood area have advised that a Braidwood South Coast Management plan has been developed but not yet been formally accepted by NPWS.

# DOYOUKNOW?

(What"Compulsory Acquisition" is?

With the National Parks Wilderness Act the government has the power to acquire land without consent of the owner...this does happen and members that have private land in the middle of National Parks have the threat of Compulsory Acquisition if and when the NPWS decide they would like it. This also happens when NPWS is pressured by extreme environmental groups to acquire further wilderness areas.

That "Old System Title" will be removed from new transfers of land purchases. This will affect the "Ripiring Zone" along river/creek beds (depending on the title)... AFA advise members to check with their solicitors... and request them to include it in their titles if need be.

#### • CHAIRMAN'S REPORT 2005-2006

AFA has had a very busy year. Apart from our monthly meetings, we have attended a host of other events, to keep AFA out in the public arena. We supported many of our members, who work in the timber industry, at a well organised day at Cobargo on the 6<sup>th</sup> August, 2005. From this day another day was organised on the 10 September so people interested down that way had the opportunity to learn more about what AFA is doing, particularly with heritage issues. From that day AFA has been able to assist others having issues with government departments in regard to access & keeping their heritage trials/tracks/huts etc.

AFA was also asked to attend a meeting at **Durras** on 4 January, 2006 in regard to the **Batemans** Marine Park. I represented AFA & explained how our group works, since then people involved and affected by this Park have formed a group to handle the Marine Park issue. I was asked again to attend a meeting on 24 January, at **Batemans** Bay Bowling & Recreation Club. Margot & I attended this meeting. On the same day we took the opportunity to meet separately with other individual groups and some Politicians.

It was a very full day, all the time pushing AFA and pointing out we are a non-political organisation, but that we must accept that almost all decisions ARE political one way or another! In the last 12 months we have had several extended meetings with Senior NPWS staff and I believe these meetings are worth the effort. It costs our members a day's wages and travelling costs and I thank them for their support. On several occasions it has been put to me that "AFA is getting too friendly with NPWS". 1 TOTALLY disagree with this view. The meetings cover a very wide range of issues with Parks management and at times discussion gets quite robust. We follow the AFA Aims and Objectives totally. Access for All finances has improved greatly over the last 12 months. The Calendar has contributed to this improved financial position. I would like to thank our Sponsors, the committee members who put a great effort into the sales and people who purchased the Calender.

AFA management committee has worked well together. Apart from financial issues, a great deal of time has been spent in trying to spread the workload over a few individual members. Almost all our members have heavy work commitments of their own to look after and it makes it very difficult to then spend a couple of hours in a vehicle to attend meetings. I cannot express enough my appreciation for the commitment of these members. If any member can put forward ideas on how we can spread this work load, I would be please to hear from you. Committee meetings are not restricted to only elect committee members – any member can come to meetings and contribute their ideas. Keeping members up to date with all issues is still the biggest task we have. I would like to thank all those members who have already renewed their Membership. Without a strong membership base it makes it very difficult for the management committee to put forward your ideas as one united group – there is strength in numbers.

If would like to see members try to introduce a new member each this year. This will build a stronger position for your committee and help us all to achieve even more.
