## - FROM THE COMMITTEE

During the introduction of the NPWS it has accumulated 783 National Parks \& reserves, a total of 6.6 million hectares or $8 \%$ of NSW. Noticeably missing on the website is the total number of wilderness hectares that the NPWS has agreed upon during that time.

The alliance between the NPWS, some members of the NPWS Advisory Committee (locally \& state level)and the Colong Foundation should be questioned often by all of us when ever the opportunity presents.
