AFA would like to be able to advise their members where these figures can be found. If anyone out there knows how they can accessed please let us know. On a lighter note the Colong Foundation is also proposing a "Discovery Ranger" program where the scouting movement, bushwalking and environment groups are asked to assist.....maybe AFA members will be able to become "rangers" and assist them with their discoveries!

What Else should you Know?

At the July AFA meeting it was brought to the committee's attention that some AFA members are of the opinion that the AFA committee is a "clicky" group. Reality is that, like so many organizations, there are the few individuals that will always put in the time required to maintain the organization. Any of AFA 500 plus members is welcome to become a committee member or come to AFA meetings. Meetings are held in different areas so members can participate, so to those feeling left out, come to our meetings and participate, we look forward to seeing you at our next meeting in Bendethera.

AFA does not organize horse riding or 4WD group outings. Individual members arrange their own outings which are not under the auspice of AFA.

AFA volunteers – To assist with track maintenance the NPWS demands certain criteria to be met by those assisting them e.g. chainsaw license and restricted number of volunteers on each outing. Thank you to those who have placed their names on our volunteers list to assist with track maintenance. AFA will endeavor to give you as much notice as possible however because the work is done with the NPWS rangers this is not always the case. Like all government departments things do not always happen as they should.

Browsing through the Dept of Environment, Conservation & Climate Change website it is alarming to note the rapid increase in New Reserves, National Parks and State Conservation areas that have been gazetted since our last newsletter in May 2010. In May there were 6, in July there were 19 and in August there are 20 already up to August 13th! Making the total number of hectares approx. 199,425.02! No doubt the green movement were concerned that there could be a change in both State & Federal leadership so

someone was making the most of our present state & federal governments. Regardless of government, the same question still presents itself, how are all these hectares being managed? When it comes time to maintain bushwalking tracks so bushwalkers are kept on a pathway so they do not disturb the flora & fauna and assists some of them from getting lost, AFA does not have any names on their volunteer list from any 'green' movements such as the Colong Foundation or The Wilderness Society.

Conservation& ecological sustainability of our bushland is a good thing, however what is concerning is the transparency of how our tax dollars are spent on managing conservation. Browsing through the Colong Foundation website alarm bells continue to ring true. Part of their program proposal is that:

- "About 2,000,000 hectares of private wilderness is yet to be purchased" and the declaration of Deua Valley and Pilliga wilderness are their first priority. The site states it would like to re-establish the Dunphy Wilderness Fund so an allocation of \$20 million, in addition, to the recurrent funding of the NPWS budget for 5 years would permit acquisition of 75,000 hectares of wilderness land at \$200 per hectare.
- They are also proposing that NPWS set up a Wilderness Unit
- Also a list of alternative routes for the Bicentennial National Trail and designation of areas for use by 4WD vehicle users and horse riders in nonsensitive Crown Lands and State Forests.
