AFA committee will endeavor to give you as much notice as possible, however because the work is done with the NPWS rangers it is not always possible to give a lot of notice. 2011 looks like a busy year ahead for track maintenance so the committee will endeavor to keep volunteers up to date. CORN TRAIL & SHOEBRIDGE TRACK - AFA's

application for another heritage grant has been successful. As mentioned in previous newsletters this will assist with the publication of our next book on the Corn Trail & Shoebridge Tracks. The project will identify, map and document two historic bridle tracks used by early settlers, so that they can be preserved and used by future generations. The amount of \$2,500 was one of the highest grants given and acknowledges the Royal Australian Historical Society's recognition of the quality of AFA's publications.

Our thanks again to Peter Smith for contributing so much of his time toward AFA and this project. Now public information is what is required to make our next publication as successful as "The Duea River Track". Members & friends are reminded to advise AFA committee members if you are aware of contacts that could be useful so this can then be passed on. Thank you also to those who have contributed so far with information.

Vandalism throughout our recreation areas continues to be a major issue, particularly in Bendethra. It is a concern of the AFA committee that the restoration project of the Bendethra horse yards will suffer the same fate as the original yards and become an easy target for those campers unable to find their own firewood. The NPWS is considering installing hidden surveillance cameras in the area.

Bendethra's popularity with outdoor enthusiast makes it obvious that the recently proposed management plan needs to be activated asap. All members and friends of AFA have the opportunity to push for state government funding for Bendethra throughout the state government election campaign happening know. AFA remains committed to having ongoing discussions with the NPWS service regarding firewood availability; extra amenities etc within the Bendethra precinct, however, we all know that playing politics will be the only way funding will be available to look after this valuable, historical area for generations to come.
